PUBLIC NOTICE TO PARENTS IN KARNATAKA

Dear Parents, Please Be Alert Before Admitting Your Child to Any School!

MUST CHECK UNAUTHORISED SCHOOLS BEFORE ADMISSION:

1. School Recognition:

- Check if the school is registered on the **SATS portal**: [STS | School Card Report](#) Ask for the **Government Registration Certificate** as per the Karnataka Education Act.

2. Unauthorised Schools:

- **Nursery/Pre-Primary schools** operating without registration under **ED 709 PGC 2018** are **illegal**.
- **Franchise models** (same name, multiple locations without separate registration) are **not permitted**.
- **Shifted schools** must obtain **fresh permission** at the new location.

3. Board Affiliation:

- If claiming **CBSE/ICSE/Other Board**:
 - Ask for an **official affiliation certificate from the claimed board**.
 - Schools must first obtain **State Government permission** to run Classes 1–8.
 - Only Classes 9–10 are under board exam control, provided all norms are followed.

4. Multiple Board Operations Are Illegal:

- A school is allowed to operate **only one board** under a single permission.

5. Fee Transparency:

- Schools **must display the fee structure** on the notice board/School premises.
- **Schools have the right to set fees in line with facilities, but:**
 - **Unjustified or steep increases** are not allowed.
 - Complaints with proof can be filed with:
 - First: **School PTA**
 - Then: **Block Education Officer / District Education Officer**

6. Zero Attendance/Non-Schooling Models:

- "Dummy Schools" providing fake attendance or multiple board names under one roof are illegal and punishable.

Admitting your child to unauthorised schools can **severely impact their academic future**. Stay informed. Demand documentation. Raise questions.
